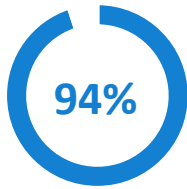


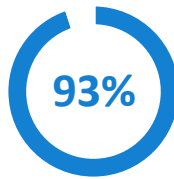

“I really appreciated the diverse viewpoints of the presenters and the many ideas for things I could do in my own work.”

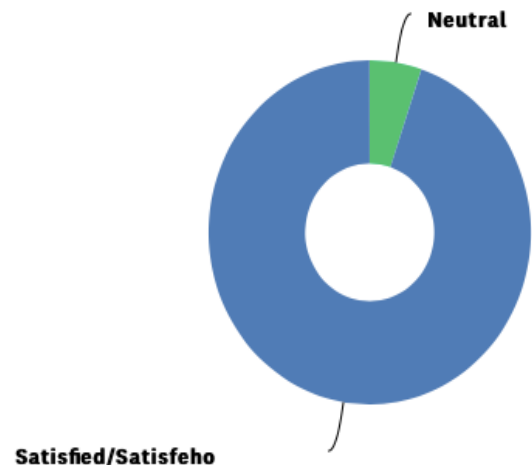

Were you able to apply the knowledge/tools gained to your daily work?

"I am a violence Prevention Educator at a DV agency. I found the information shared to be so valuable in my current work: sharing with my co-workers, processing how I can share with our survivors, and sharing portions of the training with friends that have started a Coordinated Community Response Team. I have a dry erase board behind my desk, a fluid to-do list, that still bares the quote, 'Throw out formality to remain survivor-centered' from the training."

"I feel more informed how to handle male on male abuse victims. I will be able to use the techniques I learned here to engage in community-based research projects in the future."

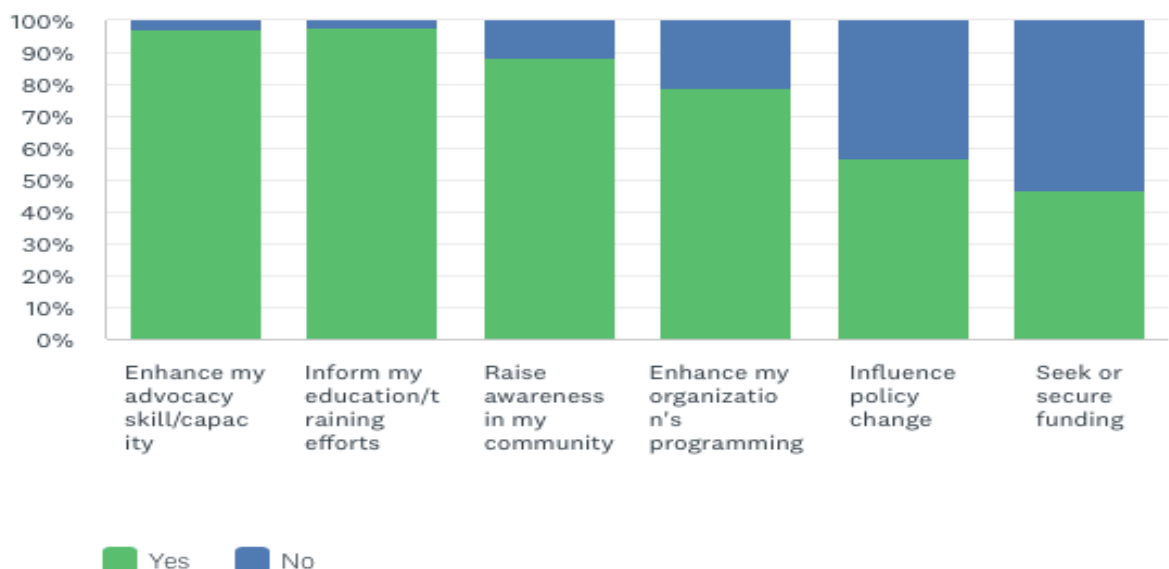
"I am a university professor – I can apply immediately by incorporating into my undergraduate social science research methods course and over the long term in developing community partnerships in an ethical manner."

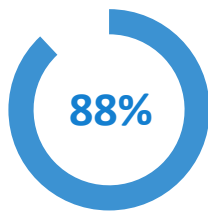
"As a sexual assault victim advocate, I plan to use/apply this information when responding to victims of all genders and sexual orientations."

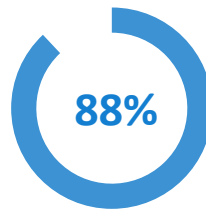

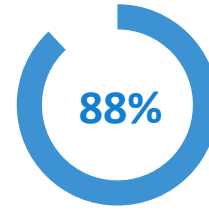

How do you anticipate your daily practice being changed as a result of this TA?

“I am more mindful about the big pictures, that these conversations need to keep happening. That we cannot control one person's individual beliefs on our own, we need to be mindful when we are making policies about how they impact people. Also, that people need to be compensated for their time and knowledge.”

“I am better able to source needed information.”

“I work in a parent education/support program for parents whose children's behavior puts them at risk of abuse and neglect. Information provided will be part of information packet provided to participants as well as used as specific resource for participants at risk of DV.”

“Timeliness of the response and information given on where to receive additional resource materials. Thank you.”

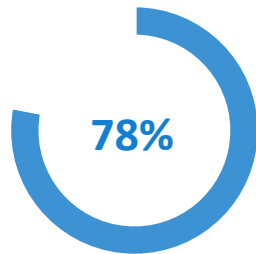
